FIRST COUNT

ATTEMPTED MURDER

FIRST DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that JADON CARTER, on or about March 9, 2021, in or about the City of Asbury Park, County of Monmouth, and within the jurisdiction of this Court, did attempt to commit the crime of Murder, by purposely attempting to cause the death of D.J., contrary to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:11-3, and against the peace of this State, the Government, and dignity of the same.

SECOND COUNT

ATTEMPTED MURDER

FIRST DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that JADON CARTER, on or about March 9, 2021, in or about the City of Asbury Park, County of Monmouth, and within the jurisdiction of this Court, did attempt to commit the crime of Murder, by purposely

attempting to cause the death of R.C., contrary to the provisions of N.J.S.A. 2C:5-1 and N.J.S.A. 2C:11-3, and against the peace of this State, the Government, and dignity of the same.

THIRD COUNT

AGGRAVATED ASSAULT

SECOND DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that JADON CARTER, on or about March 9, 2021, in or about the City of Asbury Park, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Aggravated Assault, by attempting to cause, or purposely or knowingly causing, serious bodily injury to D.J., or by causing such injury recklessly under circumstances manifesting extreme indifference to the value of human life, contrary to the provisions of N.J.S.A. 2C:12-1b(1), and against the peace of this State, the Government, and dignity of the same.

FOURTH COUNT

AGGRAVATED ASSAULT

SECOND DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that JADON CARTER, on or about March 9, 2021, in or about the City of Asbury Park, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Aggravated Assault, by attempting to cause, or purposely or knowingly causing, serious bodily injury

to R.C., or by causing such injury recklessly under circumstances manifesting extreme indifference to the value of human life, contrary to the provisions of N.J.S.A. 2C:12-1b(1), and against the peace of this State, the Government, and dignity of the same.

FIFTH COUNT

POSSESSION OF A WEAPON FOR AN UNLAWFUL PURPOSE

THIRD DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that JADON CARTER, on or about March 9, 2021, in or about the City of Asbury Park, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Possession of a Weapon for an Unlawful Purpose, by possessing a weapon, to wit: a knife, with a purpose to use it unlawfully against the persons of D.J. and/or R.C., contrary to the provisions of N.J.S.A. 2C:39-4(d), and against the peace of this State, the Government, and dignity of the same.


SIXTH COUNT

UNLAWFUL POSSESSION OF A WEAPON

FOURTH DEGREE CRIME

The Grand Jurors of the State of New Jersey, for the County of Monmouth, upon their oaths present that JADON CARTER, on or about March 9, 2021, in or about the City of Asbury Park, County of Monmouth, and within the jurisdiction of this Court, did commit the crime of Unlawful Possession of a Weapon, by knowingly possessing a weapon, to wit: a knife, under

circumstances not manifestly appropriate for such lawful uses as it may have, contrary to the provisions of N.J.S.A. 2C:39-5d, and against the peace of this State, the Government, and dignity of the same.
